## a. Youth Football in Calgary Report Greg Peterson reported:

- Dome is up and running
- Minor football numbers are coming back
- Need alumni to get involved
- In November 2022, Greg was inducted into the Alberta Sports Hall of Fame in recognition of the time he spent playing CFL football and more recently, giving back to the sport through his community involvement
  - o 2023 Calgary Booster Club Sportsperson of the year

## b. Calgary Stampeders' Football Update

Jay McNeill summarized the team for the upcoming year:

- Offensive line 4 or 5 returning
- Dave taking on GM role, Huff remains President
- Whole coach staff coming back
- Season ticket holders last year was down, they have lost 25% since 2015; lots of changes including:
  - 2023 will be a year of investment despite the decreased sales
  - A specific website has been created for season ticket holders
  - Biggest reason people didn't come back is because they don't feel there was enough value
  - Renewals locked in for 2 years
  - 15% discount for food & beverage during happy hour
  - many of the non-renewals were corporate
  - 12 CEOs will assist with marketing & promotion to gain some of these season ticket holders back through breakfasts
- Red & White Club will open for all fans, after the game with entertainment; this will integrate the younger generation; rebranded as Stamps House
  - April 18 will be a forum to explain the new stuff this year
  - Fan Fest
  - Womens' only event
  - Reunion of 1998 Grey Cup
  - May 22 pre-season game
- Question re new stadium? Any feedback?
  - No talk at this time, however they are looking to improve some things the best they can
  - It is recognized there is an issue but the University owns the property
  - Commonwealth Games would help with getting the funding in place for new stadium
- CFL needs better marketing, merchandise, online presence
  - It is recognized there is an issue but the University owns the property
  - They need to win the Commonwealth Games
